Granada Swimming Pool: Granada Owners can reserve the pool for private pool parties from 7 p.m. to 9 p.m. The cost for the Pool/Lifeguard is \$100.00.

If you wish to reserve the clubhouse and the pool, the cost is \$75.00 for the clubhouse rental and \$100.00 for the Pool. Clubhouse reservations also require a \$100.00 security deposit. Please contact Karen at the Granada Office if you wish to reserve the pool for a pool party.

## **Recent Expenditures**:

<u>Gutter Cleaning:</u> All gutters were cleaned in May, 2009. Cost \$1,975

**Bush Trimming:** Brake Landscaping trimmed all the bushes at Granada – Cost \$735

# **County Asphalt Paving:**

In June, 2009 – the parking lot at 8701-8715 was resealed – Cost \$1,169.

In July, 2009 the parking lot at 8735-8749 was resealed, Cost \$1,189.

Hot Water Heaters: Two Hot Water heaters were replaced in the apartment condominium common element laundry rooms – Cost \$1,250

<u>Balcony Painting</u> – Two recently constructed balconies were painted due to new piering work on balconies – cost \$600

<u>Piering Work</u> – <u>8720 Santa Bella</u> Due to building structural problems, Permajack was hired to install piering in the building. Total Cost of Project: \$16,525

#### **Mandatory Insurance Coverage by**

Owners: All unit owners must maintain an insurance policy covering at least \$5,000 property damage and liability (aside from any personal coverage) to cover the Association's Master Policy deductible. The Master Policy is written to cover the buildings and common elements. The unit owner suffering damage to the interior of unit will be responsible for paying this fee. Contact your agent if you have questions.
